Why OSPO OnRamp?

- Low-threshold offering for interested parties
 - No membership
 - No registration
 - Open to everyone
- Protected environment (Chatham House rule) for a really open exchange and discussions
 - We are happy if you talk about mistakes, pitfalls and disasters.
 - You can't learn without making errors.
- Generate useful content on OSPOs, with a focus on the European ecosystem, to help others getting started and mature with Open Source.

Our targets

- A regular meeting open to everyone, with a special focus on the needs of the growing European OSS ecosystem.
- For business, academia and the public sector. For organisations that just started their Open Source journey and want to learn more about OSPOs.
- A place where the experienced are there to help and support the newbies to grow and nurture the Open Source ecosystem.
- Enable organisations to become an active part in the ongoing EU-based “Digital Sovereignty” ecosystem.

Update on the OSPO Alliance

- The GGI taskforce published the v1.1 of the Handbook in November. See <https://ospo.zone/ggi>.
 - Introduces a new deployment feature to easily set up the program on any GitLab instance.
 - A translation service has been set up, and German and French versions of the handbook are already published – with more to come.
- The initiative receives a warm welcome from all over Europe: articles, conferences, translations and collaborations grow steadily.

Update on the OSPO Alliance

- The OSPO Alliance community is growing!
 - 33 member organisations, with 10 added this year.
 - Thales, Amadeus, Open Elements in the last 3 months.
- We have weekly meetings to synchronise and work on the initiative.
- 8 OnRamp sessions presented over the year: see ospo-alliance.org
- Presented the initiative and handbook in conferences:
 - OW2Con, EclipseCon Europe, OS-XP, SFScon, OpenCIO Summit.
- Press coverage: articles & news in the press.

My GGI Board

- Start working on your OSPO in less than 10mn on any GitLab instance!
 - Works on gitlab.com, and on all GitLab versions (CE, EE).
- A quick and easy way to deploy and implement the GGI method.
 - Creates activities as issues, a board to visualise them.
 - Lets you start working on the activities and write your scorecards.
 - Creates a GitLab page to communicate and report about your initiative and progress.

- Setup consultancy partnerships to help organisations deploy the GGI Handbook.

Our roadmap for 2023

- Keep updating the Handbook:
 - Add resources, review activities, add new metrics, improve the method.
- Improve deployment feature:
 - Support GitHub back-end, integrated metrics, better dashboard.
- Improve our communication:
 - Disseminate the handbook and method, reach out to more people.
 - Foster our community: set up a discussion channel, newsletter, and regular meetings for updates.
